### **PARENT QUESTIONNAIRE**

In the Autumn term when we conducted a parent questionnaire the area that came out as least positive was awareness of the work of the Governors. Our Governors work incredibly hard and are 100% committed to supporting and developing the school however we are aware that perhaps many of our parents are unaware of the work they do. Suggestions were asked about how to improve this and responses included – a termly newsletter; a termly web post; updates on the website in the Governors' section; summaries of meetings or minutes to be made available.

### **POLLUTION LEVELS**

There has currently been a lot of coverage about the pollution levels in schools and the review in North Kensington showed that levels are high. Sarah Cooper has written to the local MP regarding this mater but due to the upcoming general election the MP is unable to respond personally. After the elections the school will ensure this is followed up.

### **SCHOOL LUNCHES**

Feedback was given that the meals can be quite bland – Sarah Cooper will feed this back to the catering company. The issue was also raised as to whether food is still locally sourced as it always used to be – the school will also look into this.

Halal meat was brought back onto the menu from Monday 15<sup>th</sup> May – a letter went home regarding this on Friday 12<sup>th</sup> May.

Parents asked if feedback from pupils is taken into consideration and Sarah Cooper assured parents that children are surveyed and regularly asked for feedback which is then passed on to the catering staff.

### **MOBILE PHONES**

The school still has a no smart phone policy – we will reinforce this with pupils and parents.



### **FIDGET SPINNERS**

Children are able to bring these to school but they must be declared and put in the 'Declare Boxes.'

### **Y2**

Really positive feedback was given regarding the Y2 team and how the children have made progress this year.

### **Y6 SATS**

Positive feedback was given regarding how well the children were prepared for their SATS this year and also how the SATS week was managed by the staff. The Y6 breakfasts in the week of SATs was regarded as very positive.

### **UNHEALTHY SNACKS**

The issue was raised as to whether parents can be asked not give their children an unhealthy snack until they have left the premises. These are not banned but parents are encouraged to give their children a healthy snack.
